

## COOKIES POLICY

This Cookies Policy is an integral part of the Web Data Protection Policy of Mantis Group of Companies ( herein referred as Mantis ) and forms an integral part thereof.

We use cookies to make it easier for you to browse our website, to understand how you interact with us and, in some cases, to be able to display to you ads based on your navigation habits. Please read this Cookies Policy to understand in more detail the cookies we use, their purpose and other information that may interest you.

### **1. What are cookies?**

Cookies are small text files that are installed on your computer or on your electronic device through the browser you use when you visit [www.tsipourokalaitzi.gr](http://www.tsipourokalaitzi.gr) Cookies help us to collect the information necessary to measure the effectiveness of the Website, improve and upgrade its content, adapt it to demand and users' needs, and to measure the effectiveness of Mantis presentation and display in third-party websites. No Cookie file used on the Website collects information that identifies you personally or of any document or file in your computer. To collect and process your personal information, please visit our Data Protection Policy. The installation and use of "cookies" is specifically regulated by law (article 4 par. 5 of Law 3471/2006 that incorporated the European Directive 2002/58/EC ePrivacy), which is expected to be replaced by a Regulation (ePrivacy Regulation), in which case changes may be made to the present policy. Each website is allowed to install such a "cookie" as long as only you as the user give us **with** a positive action (opt-in) your explicit consent (under the terms of gdpr 2016/679) and with the instructions of the DPA, after clear and extensive information about this installation, the usefulness, the consequences of denial for the user experience, the purpose of the processing, the exercise of the right of access and any recipients of the data. This consent may be given through appropriate settings in the web browser or through another application. For this purpose, we provide you with the following detailed information.

The data collected by cookies may include the type of browser you are using, the type of computer, its operating system, online service providers and other similar information. In addition, the Website computer system automatically collects information about the locations you visit and about the links to third-party websites that you may visit through our website.

## **2. Cookies**

The following categories of cookies are used by [www.tsipourokalaitzi.gr](http://www.tsipourokalaitzi.gr)

### **Necessary Cookies**

“Necessary” Cookies are stored on your computer or your device during your visit to the Website and used for the smooth operation of the site. Their acceptance ensures the user’s optimal online experience while browsing and therefore it is recommended that you accept them.

### **Statistic Cookies**

“Statistic” Cookies help us understand how visitors interact with our website by collecting and reporting information anonymously. They refer to third-party cookies (Google Analytics and Google Tag Manager) and their purposes is the statistical analysis of user navigation data, the optimization of their visit experience and the better evaluation of the promotions we perform. These cookies are beyond our control and are governed by the cookies policy of each third party who installs them. You should read their respective site policies to see exactly how you should handle them.

### **Marketing Cookies**

Marketing Cookies are third-party cookies (Google, Facebook, Contact Pigeon) and aim to optimize our promotions based on user preferences and choices and optimize their online visit and experience. Based on the above, while our site does not host advertisements, our visitors may be able to display relevant promotional material on third-party platforms.

### **Session and persistent**

“Session” Cookies are stored on your computer or on your electronic device during your visit to the Site and deleted when you leave it. Persistent cookies remain on your computer or on your electronic device for a longer period of time until they are deleted by you. An example of Cookies that are necessary for us to provide our Services to you are Cookies that record your behaviors within the Site, such as your choices, demographics, products you view, and other details used to create an anonymous profile.

## **3 Purpose of processing data collected by Cookies.**

Cookies are necessary for the operation of our website. The main goal of our cookies is to improve your browsing experience. For example, cookies help us memorize your preferences (language, country, etc.) during your navigation and future visits. The information gathered by cookies enables, among other things, the improvement of the

website, by evaluating user numbers and patterns, adapting the site to individual users' interests, improved search speed, etc. In some cases, with your prior consent, we may use cookies, labels, or other similar systems to obtain information that allows us to display advertisements to you from our website or third-party websites or any other means, based on the analysis of your navigation habits.
